STANDARDS AND GUIDELINES

- Only products that are handcrafted and the applicant's own creation to be sold or displayed.
- Exhibitors must be in attendance for the duration of the Fair or they will not be allowed to return.
- Exhibitors must not sublet booth space nor act as a dealer/representative for other craftspeople or businesses.
- Sales by vendors may be subject to Vermont sales and meals tax. Please go to Vermont Department of Taxes website for rules and regulations.
- Vendors are responsible for compliance with all health and safety regulations.
- Booth space costs are \$160.00 for a single booth; \$275.00 for a double booth.
- No power is available to vendors on the Green
- No open fires are allowed
- Application Form and initial deposit of 50 per cent to be paid by April 1, 2017. Booths are subject to availability and order in which applications are received. Full payment by April 1, 2017 qualifies for the discount.
- All payments are to be sent to: **Rotary Club of Chester, VT, P.O. Box 304 Chester VT 05143.** Checks to be made payable to **Rotary Club of Chester Vermont**
- Incomplete applications will be returned.
- Full payment must be made by August, 15 2017.
- **No refunds to be given.** If a cancellation is received and full payment has not been received, the vendor will not be able to participate in future years.
- Allocation of space will be made by the Fall Festival Committee.
- Vendors are responsible for emailing photos in jpeg format along with wording and links for Facebook promotion to chesterfallfestival@gmail.com at the time of application.
